- The Committee will advise the State Government on matters pertaining to management, development and policy relating to zoos in H.P. including closure of existing unviable zoos, up-gradation and improvement of zoos and PA network, captive breeding programme, release programme etc.
- The term of the office of a member of the committee shall be three years from the date of appointment and the filling up of vacancies/ removal from committee among them shall rest with the chairman of the committee.
- The committee shall meet at least twice a year at such a place as the State Government may prescribe and shall regulate its own procedure (including quorum)
- The Committee may co-opt experts from time to time as may be required.
- The Non-official Members of the committee shall be entitled for T.A/D.A as per their entitlement / as contained in office Memorandum No. Fin.C-B-(7)-14/98 dated 10.2.1999 as revised from time to time.


