The key responsibilities of engaged retired AE/JE (Civil) will be as under:-

• To Prepare/Check the Estimates technically of various civil works of Offices/Units pertaining to the Project.

• To give guidance/technical help in execution of various civil works of Offices/Units pertaining to the Project.

Any other assignment given by CPD pertaining to the Project.

The emoluments will be purely in accordance with the office memorandum No Fin(C) –B (7)-13/2009 dated 23.03.2017 of the Finance Department. The engagement would be for a period of one year initially but can be extended further if performance found satisfactory.
